KOREAN MEETING AMIDST FINANCIAL CRISIS

Two former Prime Ministers were among 400 people who packed Seoul's Sejong Cultural Centre for the inauguration of Dr Kang Suk-kyu, as Chairman of MRA Korea. Dr Kang said that Korea's economic problems could be overcome by the practice of MRA and that he planned to gather all those who had worked for MRA before so that they could fully participate. 'Everyone should take part in solving the present Korean crisis,' he said.

Former PM, Dr Lee Young Dug, said that before the crisis there was great confidence in Korea's development and prosperity. 'In fact, our economy was full of foam', he said. There were many factors in the crisis but essentially it was caused by moral problems in the Korean people – materialism leading to greed leading to dishonesty. MRA was the solution to these problems and was the true

LOOKING AT GLOBALISATION FROM BRAZIL

The choir of the Pontifical Catholic University sang outstandingly at the opening of this month's 'Meeting of the Americas' in the stately Room Dom Pedro II, in Petrópolis' Quitandinha Palace. During the following five days, the Meeting tackled themes crucial to the life of the continent.

The session on 'Life in the communities – problems, answers and opportunities' featured social activist Sergio Sanchez from Mexico, community leaders Ana Marcondes and Luiz Pereira from Rio; and from Petrópolis Dr Regina Celi, Secretary for Social Work, and Town Councillor Dr Maia.

the theme of business ethics and the challenge of grobalisation was tackled by Dr Jones Santos Neves, Erwin Zimmermann, Hector Garcia from Mexico and Dr Decio, President of an emerging Independent Workers Confederation.

The next day Dr Maria Raimunda Azevedo, a Judge working with the Vice-President of the Supreme Court of the State of Rio, led a session on 'The contribution of the legal system'. The panel included lawyers from Minnesota, England and Petrópolis.

That evening 30 young people, descendants of the German settlers invited by Emperor Dom Pedro I to help build Petrópolis, presented traditional German and Austrian dances, managing to include almost all the participants in the intricate choreography.

On the last day a taxi driver and several community leaders were among many who came spontaneously to the platform to speak of their discoveries and their hopes. Mr Sanchez summed the gathering up, describing it as 'a refreshing, inspiring time that has given me an idea of what can be done, with the help of God, in my country and the continent'.

AN INTERNET INNOVATION

An Indian industrial executive decided at the Asia Pacific Consultation last month to go online once a month to share thoughts from his quiet time with a Sri Lankan peace activist. This triggered others and, before the Consultation was over, a network of trans- national sharing partnerships had been established.

The Consultation brought 34 people to Asia Plateau from 13 countries. By the end of our days together, we had decided to take on wholeheartedly an initiative proposed by Taiwanese friends, to offer people between 20 and 40 years old a year of training and outreach with MRA. Beginning in the year 2000, it will start with three months at Asia Plateau, followed by three months working in an Indian city, then elsewhere in Asia. The initiative will continue for five years.

We also decided that the next Asia Pacific Youth Conference (APYC) will be held at Asia Plateau in January. A special effort will be made to invite youth from Sri Lanka and Indonesia.

Asia Plateau will be the base for a six-week international Effective Living Course, starting on 8 January 1999.

A fund known as the Ma Mi Memorial Fund will be established to help towards the needs and programmes of those working with MRA in Asia.

From January of next year, Asia Plateau's Creative Leadership programmes will be opened to industry in other countries of Asia and the Pacific.

To take things forward, a Facilitation Group has been formed. Those who will serve for the first year are Lauren Tate-Davis (NZ), Rob Wood (Australia), Leena Khatri (Fiji), Rahul Kapadia (India), Kiyoshi Nagano (Japan), David Young (UK) and Grace Liu (Taiwan), who will be Secretary. A representative from outside the region has been included to ensure good links with the global team. Becoming a world team through a renewal and expansion of commitment, and wanting to be connected with other areas, was a feature of this Consultation.

Against the background of economic disaster, we discussed the situation in several areas, particularly Sri Lanka and South Korea.

A key thought that helped us all was:

'I often hesitate to take on things saying that others do it better. Of course many others do it better but then they also get over-burdened. The question is – Will I do my best – and grow through it?'

What next? We have been urged to continue the campaign in the name of Clean Kenya Campaign. We are establishing this at present, and are planning a national aference in May in Nairobi.

A NEW PHASE?

The imminent completion of arrangements to move to a new and exciting MRA centre in London seems to me another tangible sign of God's promise that He has a wholly new phase in store for us. As we quest for renewal in our world work, and with the approaching Jamaica consultation as a step in this process, I see this new phase not only as a development but also qualitatively different, appropriate to a changed world. It will also be utterly true to the essence of what God gave the world through Frank Buchman. But I don't believe that we will slip into this phase by redoubling our efforts, sharpening up a little here and there.

God means to give us a quantum shift, a deep individual and collective change, a spiritual rebirth, as well as a renewed sense of vision for the future.

Renewal involves letting go. In order to accept the gift of a new phase, what will each of us be ready to let go? For me there have been resentments and hurts from the past to relinquish, as well as my love of comfort and approval. The up-side of this letting go is that trust is built, and bigger aims can be taken on with responsibility and confidence. It seems to be a spiritual law that the fullness of God's plan is not revealed until blockages are removed. Unresolved relationships, for instance, generate cynicism, and cynicism dissolves the power of all fresh vision before it can take hold.

How can we more fully become a fellowship of people who help each other go deeper in our givenness to God?

Have we too much become people who are each 'for their own thing'? How can we become people who are ready if needed to sacrifice 'their own thing' to 'our thing' as revealed to us together by God? This will not happen through cajoling, or exercising human authority – but only as a fruit of deeper spiritual renewal and a rebirth of trust between individuals.

These are issues I see as central to the Jamaica consultation. Individual and collective renewal may not only be a prerequisite for finding the new phase, but may in fact be the essence of that phase. We need not greater effort, but greater receptivity. God is surely wanting to give some mighty gifts and blessings which will deepen, sharpen and unite. Are we ready to receive them?

CAUX 1998 MRA MEDIA MEETING

- Coordinating and improving MRA's presence on the World Wide Web.

The meetings last summer strengthened our international network. We benefited greatly from ICF participants who stayed on to meet with us, and we hope to include several again from this circle.
